NOTICE AND DESCRIPTION OF SHELLFISH AREA CONDEMNATION NUMBER 052-151, BACK CREEK – YORK COUNTY

EFFECTIVE 15 JUNE 2025

Pursuant to Title 28.2, Chapter 8, §§ 28.2-803 through 28.2-808, § 32.1-20, and § 2.2-4002, B.16 of the Code of Virginia:

- 1. The "Notice and Description of Shellfish Area Condemnation Number 053-151, Back Creek York County," effective 15 May 2024, is cancelled effective 15 June 2025.
- 2. The "Notice and Description of Shellfish Area Condemnation Number 053-221, Chisman Creek," effective 15 May 2024, is cancelled effective 15 June 2025.
- 3. Condemned Shellfish Area Number 052-151, shown as Sections A and B, is hereby established effective 15 June 2025. It shall be unlawful for any person, firm, or corporation to take shellfish from these areas for any purpose, except by permit granted by the Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of these areas are shown on the map titled "Back Creek York County, Condemned Shellfish Area Number 052-151, 15 June 2025" which is part of this notice.
- 4. Conditionally Approved Shellfish Area (seasonally closed status) Number 052-151, shown as Sections M1 through M3, is hereby established effective 15 June 2025, and shall remain in force annually thereafter for the period beginning the first day of April through the last day of October until rescinded. It shall be unlawful for any person, firm or corporation to take shellfish from these areas during such period for any purpose while in the closed status, except by permit granted by the Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of these areas are shown on the map titled "Back Creek York County, Condemned Shellfish Area Number 052-151, 15 June 2025" which is part of this notice.
- 5. The Department of Health will receive, consider and respond to petitions by any interested person at any time with respect to reconsideration or revision of this order.

BOUNDARIES OF CONDEMNED AREA NUMBER 052-151

A. The condemned area shall include that portion of Back Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°12'17.4",-76°26'23.8") and map coordinate (37°12'13.1",-76°26'25.8").



- B. The condemned area shall include all of Bay Tree Creek upstream of a line drawn between latitude / longitude map coordinate (37°11'17.1",-76°23'35.8") and map coordinate (37°11'16.4",-76°23'35.9").
- M1. The conditionally approved area (seasonally closed status) shall include that portion of Back Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°12'10.4",-76°25'37.8"), map coordinate (37°12'14.0",-76°25'39.4"), map coordinate (37°12'18.0",-76°25'25.7"), and map coordinate (37°12'14.9",-76°25'24.3").
- M2. The conditionally approved area (seasonally closed status) shall include that portion of Back Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°12'19.1",-76°25'08.6"), map coordinate (37°12'21.7",-76°25'09.8"), map coordinate (37°12'24.0",-76°24'59.2"), and map coordinate (37°12'19.1",-76°24'57.8").
- M3. The conditionally approved area (seasonally closed status) shall include that portion of Back Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°12'17.6",-76°26'15.6") and map coordinate (37°12'18.8",-76°26'04.5").
